

The Health and Safety Executive's (HSE) have produced guidance on managing work-related road safety and is freely available on their website <u>www.hse.gov.uk/</u> <u>roadsafety/</u>. It sets out the legislative framework associated with driving at work and provides clear guidance on what a company and individuals are required to do.

Vehicles produced today are built to a standard which provides maximum safety features. However, despite these advancements, every day vehicles are still involved in crashes with people being killed or seriously injured.

The reality is over the past 10 years, the number of people dying every year whilst driving at work has remained the same – the cost in human and financial terms is considerable and impacts lives and businesses.

The introduction of the fully integrated FSGB Driver Management programme – will produce considerable benefits including a safe driving culture that supports a genuine commitment to driver's wellbeing.

There has never been a better time to get it right and to make sure within a business that fleet costs are identified and strictly managed.


The reality is that in many organisations 20% of drivers are responsible for 80% of fleet maintenance costs and also negatively influence other areas of fleet related expenditure.


### What is the Key Aspect of the Programme


